A product supply agreement should include both price and payment terms For short-term agreements, it is often better to agree to a set price For long-term agreements, it may be better to provide for a changing price For example, a long-term contract could specify a discount from the supplier's list prices, or refer to a published commodity

SUPPLIER AGREEMENT (PRODUCE)

breach of such agreements, terminate any other agreements between the parties regarding the supply of goods and may remove Supplier from any approved supplier program Execution of this Agreement by the parties shall not be deemed a commitment on the part of Buyer to purchase goods from Supplier or of Supplier to supply goods to Buyer
